

Dallas Women's Foundation Celebrates 25 Years in 2010

The celebration of our 25th anniversary calls for us to reflect on the past, present and future of the Foundation. When we created the Foundation in 1985, our goal was to become a permanent, reliable source of funding for programs that advance self-sufficiency for women and girls. We have exceeded our own expectations.

In 1985, DWF made seven grants totaling \$23,500 and secured \$85,000 in assets. This year, we are granting more than \$2 million back into the community and our assets have passed the \$25 million mark—this during a time when most foundations are curtailing grants. The times demand more and the Foundation is able to provide more because of the continuing support of our generous donors.

Because of that support, the Dallas Women's Foundation is now, in terms of assets, the largest of the 150 women's foundations worldwide!

We are in year four of our five-year \$30 million Comprehensive Campaign, so ably chaired by Cecilia Boone. We have already raised \$29 million and secured an additional \$26 million in planned gifts. Thus far, DWF has received 20 gifts of \$1 million or more, as well as thousands of gifts of personal significance at all levels. On page 9, learn more about some of our faithful donors who have invested in the success of the Foundation over many years.

Our new strategic plan calls for DWF to enlarge its community footprint through targeted grant making, gender-specific research and philanthropy education programs. We are particularly focusing on strategic partnerships. For example, we are part of a funders' collaborative investing grant dollars in programs that prepare young children for school. This "Zero to Five" collaborative will provide, test and measure various interventions designed to increase children's English vocabulary by the time they enter kindergarten.

We applaud our founders, our donors and our volunteers who have brought us to this joyous time in our history. Please join us in celebrating 25 years of growth and community leadership and help us create DWF's dream for the next 25 years!

As we embark on these challenges, we are proud that our organization has become a leader in our work. We intend to continue to demonstrate our leadership by generating the most impact through targeted grants, gender-specific research and philanthropy education for women. With your continuing support, we will keep the promise our founders made so many years ago—to enable women and girls become strong, independent, contributing members of our community, which helps us all.

Campaign Summary

Our five-year, \$30 million comprehensive campaign now stands at \$29 million raised. In addition to the \$29 million raised, we have also secured \$26 million in planned gifts or gift expectancies during the campaign. This campaign has enhanced and doubled the grantmaking capacity of the Dallas Women's Foundation, expanded the research and women's philanthropy programs, and increased the endowments and investment assets of DWF, making us a permanent financial resource for women and girls in our community.

As part of the campaign, we have received 20 gifts of \$1 million or more—which positions us as a leader among women's foundations and makes us now the largest of the 150 women's foundations worldwide, in terms of our assets. Our assets (investments and pledges) now stand at \$25 million.

Overview

- \$30 million goal.
- Comprehensive – all commitments and gifts, including luncheon, annual campaign, endowment funds and planned gifts, count.
- Gift planning is a cornerstone of this campaign and all planned gifts are recognized.
- 5-Years – All commitments and gifts made during July 2006 – June 2011 are recognized.
- All donors and gifts are valued.

Milestones

- 19 donors have made 20 gifts of \$1 million or more.
- Another 22 donors have made gifts of \$100,000 or more.
- Many others have made incredible gifts of personal significance.
- There are 51 members of the Quantum Leap Circle—minimum gift of \$10,000 annually for at least 3 years to support the expansion and enhancement of the Dallas Women's Foundation programs and operations.
- 31 Donor Advised Funds—Donor Advised Funds are funds maintained by the Dallas Women's Foundation. The donor makes an irrevocable gift (minimum \$50,000) to establish the fund. He or she will receive an immediate tax deduction and may make recommendations on the funds distribution.
- 3500 campaign donors.

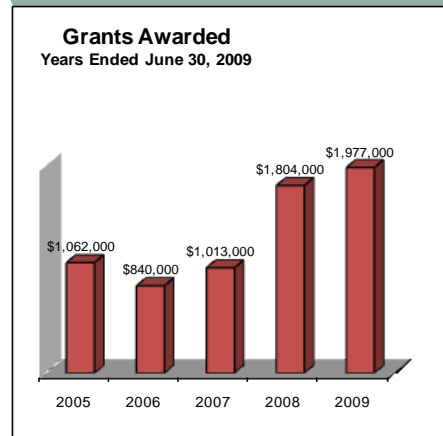

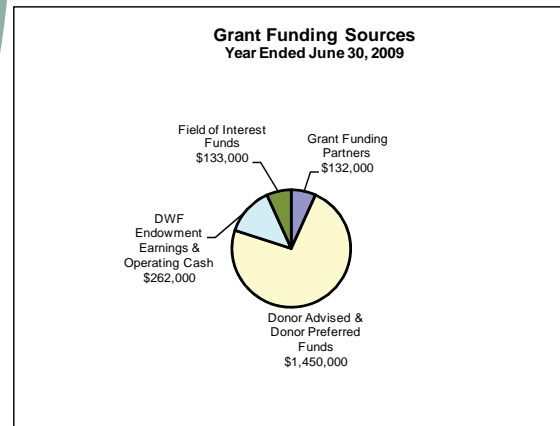
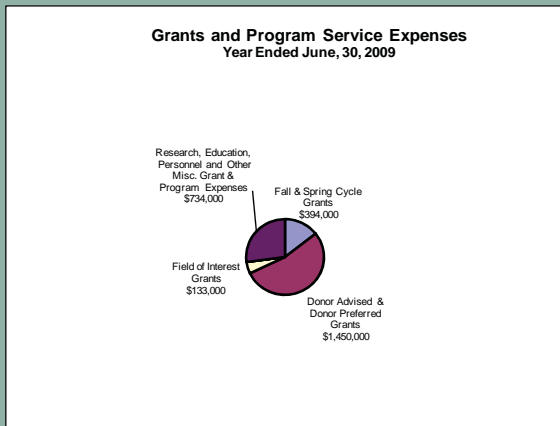

Education & Training



- Program services include: Emerging Agency Leadership Institute; research; women's philanthropy education; Faith, Feminism and Philanthropy program; and miscellaneous program expenses.
- Biannually, DWF makes grants based on a thorough review process that includes application submissions, financial reviews, site visits, and an ultimate review by trained volunteer researchers.
- DWF nurtures young nonprofits through the Emerging Agency Leadership Institute. Since its inception, this program has helped 58 agencies through training, mentoring, and dedicated funding.
- Donor Advised Funds (DAF) – The person, family or organization that established the fund at the Dallas Women's Foundation recommends grant recipients from the fund for the Board of Directors' approval. Grant awards may be made outside of Dallas, Denton and Collin counties and each year a minimum of 50% of a DAF's grant awards must be made to programs serving women and girls.
- Field of Interest Funds – Grants from these funds support a particular interest area under the larger women and girls umbrella, specified by the person, family or organization that established the fund with the Dallas Women's Foundation.

Make a Gift of Personal Significance Without Writing a Check

- Make a gift of long-term, publicly traded stock that has appreciated to your charity of choice and receive two tax benefits: charitable income tax deduction and avoidance of capital gains tax.
- Purchase a gift annuity which pays you income for life. You may be able to use publicly traded stock to set up the annuity.
- Make a gift of your private company stock to a charitable remainder trust that will produce income for you.
- Gift a paid-up insurance policy.
- Make an outright gift of real estate (e.g., your home, vacation home or undeveloped property).
- Convert your home, vacation home, or undeveloped real estate into a gift and annual stream of income using a charitable remainder trust.
- If you are age 70 ½ or older, transfer a portion of your IRA (\$100,000 maximum) to your charity in lieu of, or in addition to, your required minimum distribution.

Gifts of Personal Significance

The word “philanthropist” often brings to mind a wealthy individual giving millions of dollars to charity. Certainly those types of philanthropists exist – but the majority of philanthropists are just everyday people giving what they can to make a difference.

As Cecilia Boone, co-chair of the Dallas Women's Foundation campaign points out, “Giving should be an alignment of strategy and joy.”



PORTRAITS OF WOMEN PHILANTHROPISTS

Brenda Brand: Making the Stretch to Make a Difference

Brenda Brand first got involved in Dallas Women's Foundation 20-some years ago when a friend suggested she volunteer. She began by serving on the grants committee and attending the annual luncheon. “When I saw how little funding was going to women's causes, I wanted to help fill that need,” says Brand. Soon she found herself stretching to make her first large donation to a cause, which she describes as “a stretch” at the time. “The Dallas Women's Foundation is one of my great loves,” says the former board president and co-chair of the DWF Advisory Council. “I am proud of what we do in the community, and I have learned a tremendous amount about giving and asking for money. Now I can say I'm part of the ‘old girl network.’”



Sheila Gallagher: Aligning Her Giving With Her Values

Sheila was recruited to join the DWF board in 1995 by then Executive Director Pat Sabin and has been both a donor and a volunteer ever since. “I have watched the Foundation develop over many years,” she says. “I am constantly inspired by its positive impact both on those who have resources to share and on those who need those resources. On a personal basis, DWF has helped me discover the satisfaction of giving. I love knowing my contributions will make a difference in someone's life.”

Catalina Garcia: Women Helping Women

When Dr. Catalina Garcia was ready to start her medical practice, she couldn't get a loan to buy insurance without her husband's signature. One of the only women and the only Latina in her med school class at UT Southwestern, she saw first-hand the need for change for women. Times have changed, but her commitment to women's issues has not. “Dallas Women's Foundation has always been number one on my charitable giving list,” said Garcia, who is one of the founders of the organization. “I love being part of women of all different walks of life and different giving capacities helping other women. When you look at the programs that Dallas Women's Foundation supports, their services are so needed.”



Paula Parker: Making Every Dollar Count

When Paula Parker was a maternal and child health nurse at Parkland, she saw the needs in the community first-hand. “I knew I wanted to do something to help women and children in the community,” she said. “Then, when I got to know the women at Dallas Women's Foundation, I had such respect and awe for what they were doing.” The cause drew her in, but she credits the organization's stewardship of her dollars as what brought her back year after year. “Every nickel I give is used as best it can be. Dallas Women's Foundation is a very good steward of my donations, and I love that,” Parker said. “This has helped me to see that you don't have to have thousands to make a difference for a worthwhile cause.”

Gender Matters: An Analysis of the Texas State Budget

On February 9, the Dallas Women’s Foundation hosted an issue forum about the impacts of the Texas state budget on the health, safety, education and economic security of women and girls. Featuring feminist economist Diana Strassman from Rice University and senior budget analyst Eva DeLuna Castro with the Center for Public Policy Priorities (CPPP), the conversation focused on a new report about the 2010-2011 state budget as viewed through a gender lens. Highlights of this study include:

- Regressive tax policies in Texas place a disproportionate financial burden on female-headed households.
- State investments in health and safety programs for Texans consistently rank among the lowest in the nation, ensuring that our women and girls have the worst health care access in the U.S.
- Texas ranks 44th among the 50 states in public education spending per student and 50th in the share of adult women with at least a high school diploma.

The report also considers actions needed to improve the outcomes for women and girls in our state. We will keep you informed as we learn new ways to address public finance and policy in Texas.

The report was conducted by the CPPP and DWF and underwritten by the Cecilia and Garrett Boone Family Fund.

Domestic Human Trafficking: Exposing an Epidemic

Recently, the Dallas Women’s Foundation has dedicated time and resources to shed light on a growing and troubling epidemic: Domestic Human Trafficking. Described by Dallas blogger and entrepreneur Jennifer Conley (iliveindallas.com) as “a topic that breathes fear and exhales suffering,” it is an issue that can no longer stay hidden in the shadows and must be exposed. “[The fact that] 300,000 women and children are being exploited for sex in our country deserves a headline story...on cnn.com,” states Conley. This story is truly horrifying. The Foundation hopes to work with multiple organizations to bring various experts to Dallas in different mediums, in order to reach multiple audiences with this information.

Last November, DWF partnered with Women in Film Dallas to bring “Playground,” a documentary following the story of trafficking victims in America and examining the United States’ influence by interviewing activists and experts in this field. More recently, in February, DWF was honored to be one of the sponsors for CHILDREN AT RISK’s Texas Summit on the Trafficking and Exploitation of Children. The purpose of this event was to educate the community on the state of the anti-trafficking movement in Dallas, particularly the domestic child sex subset, and what solutions exist to end this crisis.

Human Trafficking is the recruitment, harboring and/or transportation of human beings, for the purpose of exploitation, slavery and/or indentured servitude. Victims may be illegal immigrants, legal immigrants or US citizens and the exploitation can be for commercial sex trade or forced labor.

Domestic child sex trafficking is a subset defined as runaway youth, throwaway youth and homeless youth. One out of every three teens will be lured toward prostitution within 48 hours of leaving home. The average age is 13 and the audience is overwhelming girls. There are an estimated 6,000 runaways in Dallas County annually. (CHILDREN AT RISK)
